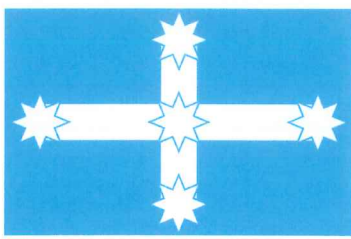

The Union services a large variety of awards and Enterprise Agreements and covers Plumbers, Gasfitters, Drainers, Roof Plumbers, Sprinkler Fitters, Apprentices, Laborers and many other related categories. The main strength and achievements of the Union can only be maintained with the active and informed participation of the members.

The Union was registered in 1917 as a Federal Union and covers the trade in all states of Australia. The Union is registered under the Workplace Relations Act 1996, which covers all Federal Awards. It is also registered under the New South Wales Industrial Relations Act 1996 that looks after all State Awards.

**Services To Members**

Industrial negotiation and representation relating to your rate of pay and conditions of employment. In addition to appearing before the relevant industrial tribunals, organizers and industrial officers visit places of employment to speak to members, to inspect working conditions, and to check employer's salary and time records to ensure members are receiving all their entitlements.

Legal assistance and representation where necessary in matters arising from and in relation to a members employment. This service may include:

- Intervening on your behalf in an industrial dispute with your employer e.g. unfair dismissal.
- Free and complete assistance with workers compensation matters. The Union's lawyer will also give the first consultation free on any matter.
